RWAV is launching its first Photography Competition (the Competition).

1. By entering the Competition, the entrant accepts and agrees to be bound by these Terms and Conditions (Terms).
2. To be eligible to enter the Competition, the entrant must be a practising medical/health professional (or an immediate family member) or a non-health professional employed in a general practice in rural Victoria and have personally taken the photograph(s) that he or she intends to submit.
3. The Competition will close at 5.00pm on Wednesday 31 October 2018. Late entries will not be accepted.
4. Up to five photographs may be submitted by any entrant.
5. Entries, along with a fully completed entry form for each image, may be submitted:
 - a) electronically to RWAV at communications@rwav.com.au (up to 10MB per email); or,
 - b) posted to the Communications & Marketing team at Rural Workforce Agency Victoria, Level 6, Tower 4, World Trade Centre, 18 -38 Siddeley Street Melbourne VIC 3005.
6. Entries must be high-resolution (300dpi) and will not be returned.
7. To be eligible to enter the Competition, the photograph(s) must be in a high resolution format (ensure your camera is set to the highest quality) which can be reproduced for high quality print and be in line with the theme 'This is Our Community.'
8. Entries which do not comply with these Terms will not be accepted.
9. RWAV takes no responsibility for lost or late entries or corrupt digital files.
10. It is the entrant's responsibility to obtain the necessary permissions from people who appear in a photograph.
11. Images should depict natural photography; this includes natural landscapes and people with natural expressions. Imagery should celebrate the natural beauty of rural Victoria and the people who live there.
12. By entering this Competition, the entrant warrants that such permissions have been obtained in writing and agrees to provide copies to RWAV upon request.
13. Entries may be submitted in both landscape and portrait orientation; however, RWAV prefers entries that are of landscape orientation due to the size requirements of the desk calendar.
14. Twelve entries will be selected for inclusion in the RWAV 2019 desk calendar, along with the name and picture of the photographer.
15. Entries selected to feature in the desk calendar may need to be cropped to suit the size requirements of the desk calendar.
16. All entrants to the Competition agree to give RWAV the right to reproduce their image in print and online marketing material, to promote awareness of rural Victorian health careers. This right is non-exclusive, and images will not be shared with any third party, or used for profit.
17. Where reasonable (in RWAV's view), photographs published under these Terms will include a photographer credit.
18. One major prize will be awarded to the winner of the Competition. The winning photographer will receive a \$500 camera store voucher (Michaels or Teds camera store) and a framed copy of their winning photograph. The winning photograph will feature on the cover of the RWAV 2019 desk calendar.
19. All entries will be judged after the Competition closing date by a panel of judges. The entries will be judged as capturing the subject matter in the most creative manner. The top 12 entrants will be contacted following the competition closing date advising them of successful selection.
20. RWAV staff members and their families are not eligible to enter the Competition.
21. RWAV's decision is final and no correspondence will be entered into.
